  - Participants Code of Ethics reviewed
  - Participation in one Fundraiser.
- Parental and Legal Guardian participation is required to make this program operate. Please make sure Volunteer Choices were circled on the front of this form.
- Legal Guardians are responsible for gathering information. The officers of WJW are also volunteers and make every effort to get information to the Participants and Legal Guardians. Please help out.
